

Lifetime Limited Residential Furnace Warranty

Metromatic Manufacturing Co., Inc.
organized under the laws of the Commonwealth of Massachusetts

Hereby Warrants

this Metromatic Furnace to be free of defects in material or workmanship.

This warranty is extended only to the original purchaser(s) (purchaser) whose name(s) appear(s) on the "record of purchase" card returned to and on file with Metromatic Manufacturing Co., Inc. (Metromatic) within thirty days of date of installation.

During the first twelve months after installation, all parts of the furnace are warranted with the exception of air filters. Within this time period, Metromatic will replace or repair at its option any defective part. Instructions for returns will be issued by Metromatic to avoid transportation charges to purchaser. Beyond one year no other parts are covered except the furnace heat exchanger.

Beyond the first year, the heat exchanger carries a Limited Lifetime Warranty. If at any time during the warranty period the heat exchanger becomes defective, Metromatic will, at its option, repair or replace it free of charge. Any transportation fees will be the responsibility of the purchaser.

All warranties set forth herein do not include labor or service charges involved in the removal of a defective part, the installation of a repaired or replacement part, nor any other work not performed by Metromatic. Within the meaning of said warranties, a defect of any component part capable of being repaired or replaced shall not cause the entire furnace or any other part thereof to be deemed defective.

No representative of Metromatic Manufacturing Co., Inc. nor any of its distributors or dealers has any authority to alter in any manner the terms of this Warranty.

The conditions of this Warranty are:

- (1) The furnace must have been installed by a licensed heating contractor according to Metromatic's specifications and instructions.
- (2) The furnace must have been operated within its listed capacity.
- (3) The correct use and proper operation of an approved automatic control to limit the air temperature in the furnace to a maximum of 200° as specified by the National Board of Fire Underwriters.
- (4) The heating system was installed in accordance with the recommendations of the National Warm Air Heating and Air Conditioning Association.
- (5) The furnace has not been moved from the site of its original installation.
- (6) Air from a Summer Cooling Unit must not have been circulated over the heating element of the furnace.

FAILURE TO COMPLY WITH ANY OF THE ABOVE CONDITIONS WILL VOID ANY AND ALL WARRANTIES LISTED ABOVE.

With the exception of the foregoing and unless specifically expressed in writing, Metromatic makes no express warranties, no warranty of merchantability, nor any other warranties. This warranty shall not apply to a furnace which has been subject to accident, alteration, abuse or misuse, or which has been damaged as a result of fire, flood or other acts of God. Further, in no event will Metromatic be liable for any incidental or consequential damage of any nature.
